RELEASE AND WAIVER OF LIABILITY AGREEMENT

By Participant or Legal Guardian Thereof

PLEASE READ THIS CAREFULLY

I, _____ hereby release, waive and discharge the Yurok Tribe and all people involved with or associated by the Yurok Tribe (hereinafter RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any media Production, photos, commercials, damage, or injury that may be sustained by myself, or my child or ward, or to any property in the possession of myself, or my child or ward, while riding in a Yurok Tribal vehicle or participating in a Tribally sanctioned activity.

I am fully aware of the risks and hazards connected with participating in this activity, including the risk of physical injury or disability as the result of such injury, and I hereby voluntarily participate, or approve of my child or ward, participating in this activity. I voluntarily assume full responsibility of any risk of loss, property damage, or personal injury that I, or my child or ward, may sustain, or any loss or damage to property in my, or my child or ward's, possession as a result of being engaged in such activity.

I further agree to indemnify and hold harmless the RELEASEES from any loss, liability, damage, media production, commercials, photos or costs that may incur due to my, or my child or ward's, participation in said activity.

It is my express intent that this RELEASE AND WAIVER OF LIABILITY shall bind the members of my family and spouse (if applicable), if I am alive, and my heirs, assigns, and personal representatives, if I am not alive, and shall deemed a release, waiver, and discharge of the RELEASEES. I hereby further agree that this RELEASE AND WAIVER OF LIABILITY AGREEMENT shall be construed in accordance with Tribal, state, and federal laws.

I understand the RELEASEES will not be held responsible for any medical costs associated with an injury I, or my child or ward, may sustain.

Nothing in this agreement shall be deemed or construed to be a waiver of the sovereign immunity of the Yurok Tribe, its officials or employees acting within their official or individual capacities.

By signing this waiver I release all rights to any media production, commercials, photos, radio spots be used by the Yurok Tribe for promotion purposes.

Acknowledgement of Understanding:

I acknowledge that I have read the RELEASE AND WAIVER OF LIABILITY AGREEMENT and fully understand its terms. I affirm that I am voluntarily participating or approving of my child or ward's participation, in this activity and further acknowledge that I know, understand, and appreciate the inherent risks of participation. I assume full responsibility for any and all injuries or damages that may occur to me, or my child or ward, as a result of the inherent risks associated with participation.
